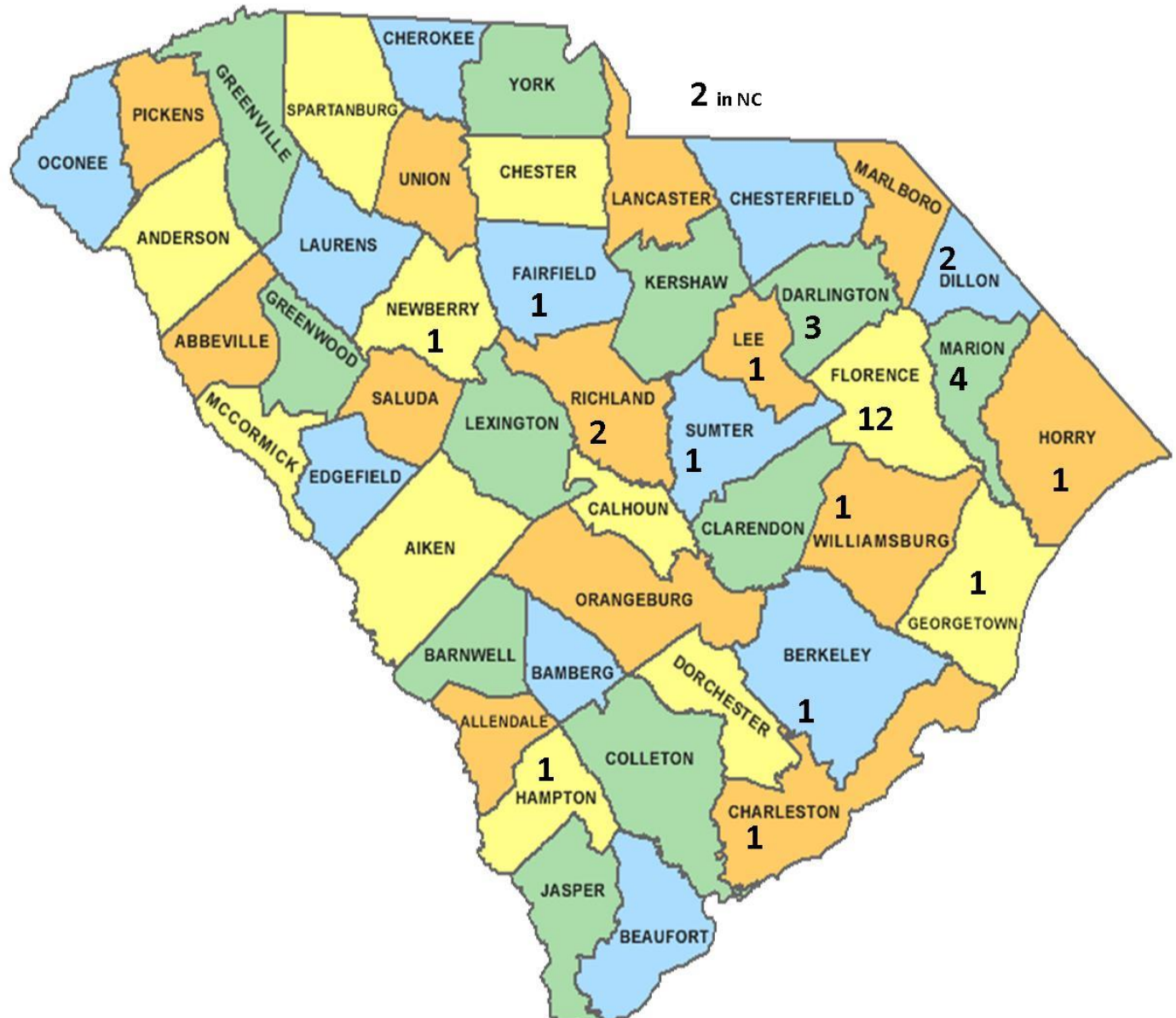

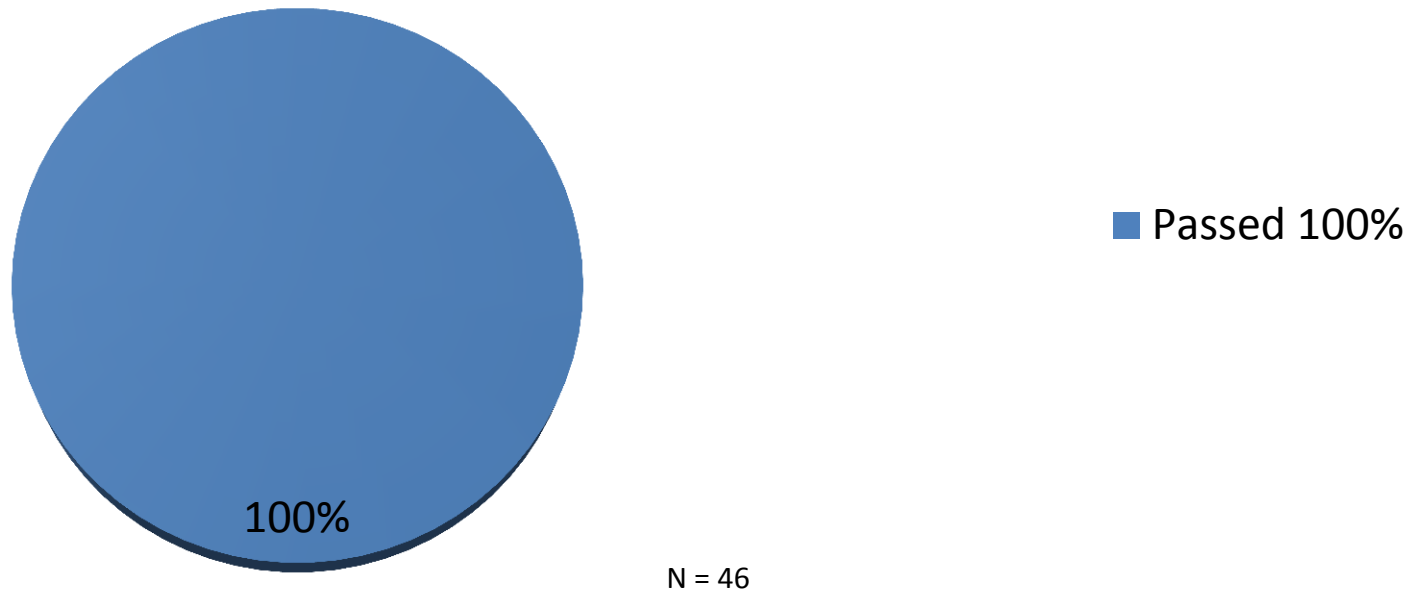

Graduate Performance on Licensure Exams

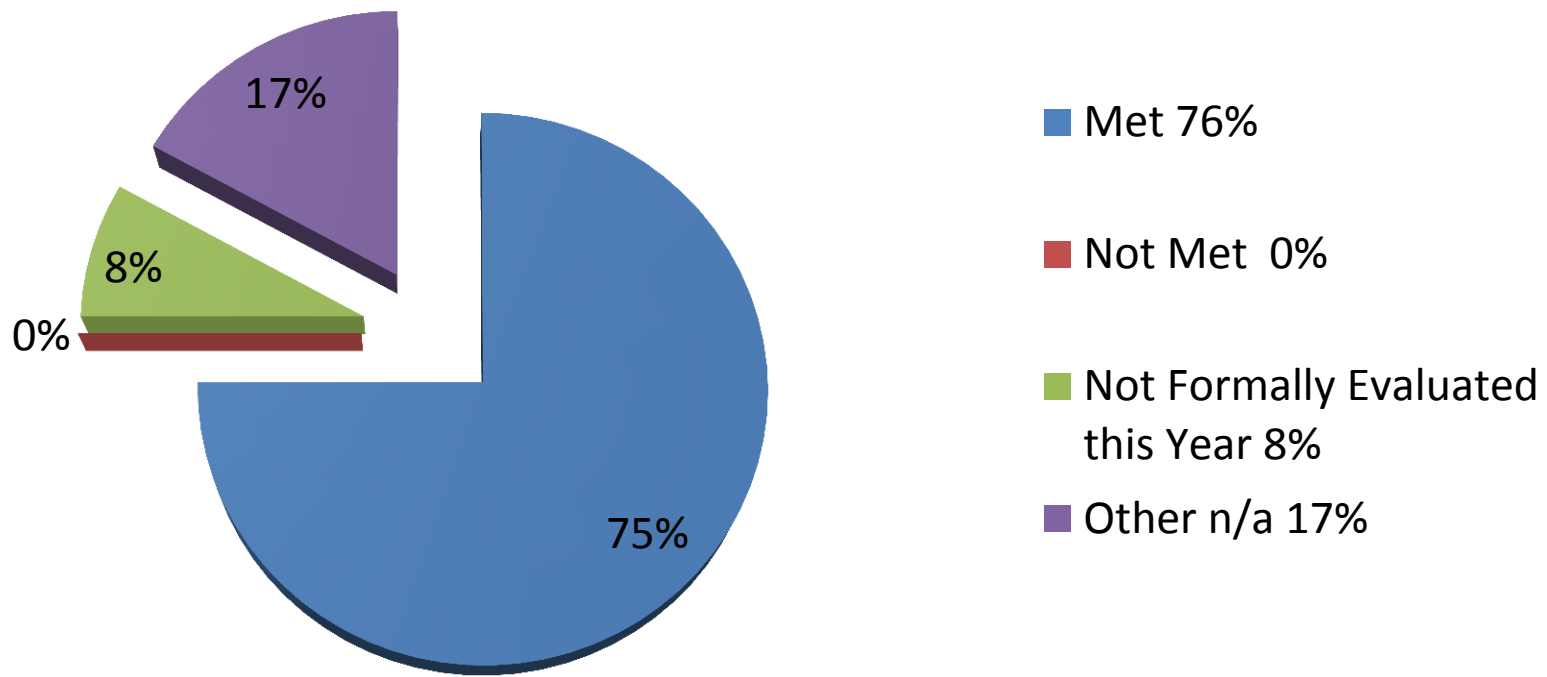
100% of the 2013-2014 Graduates passed the licensure exams required to teach in South Carolina.

The 2013-2014 completers earned the following evaluation results during their first year of teaching.

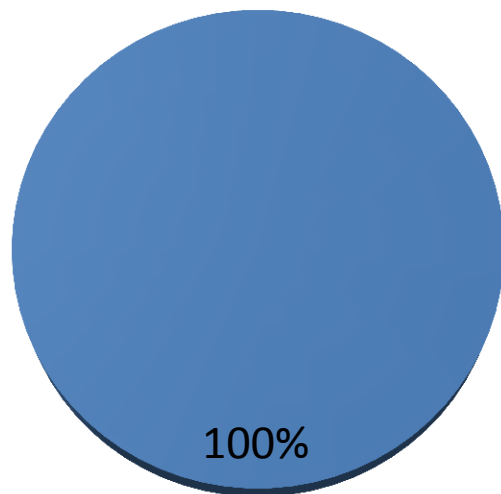

Percentage of our 2013-2014 completers who plan to continue to teach next year?"



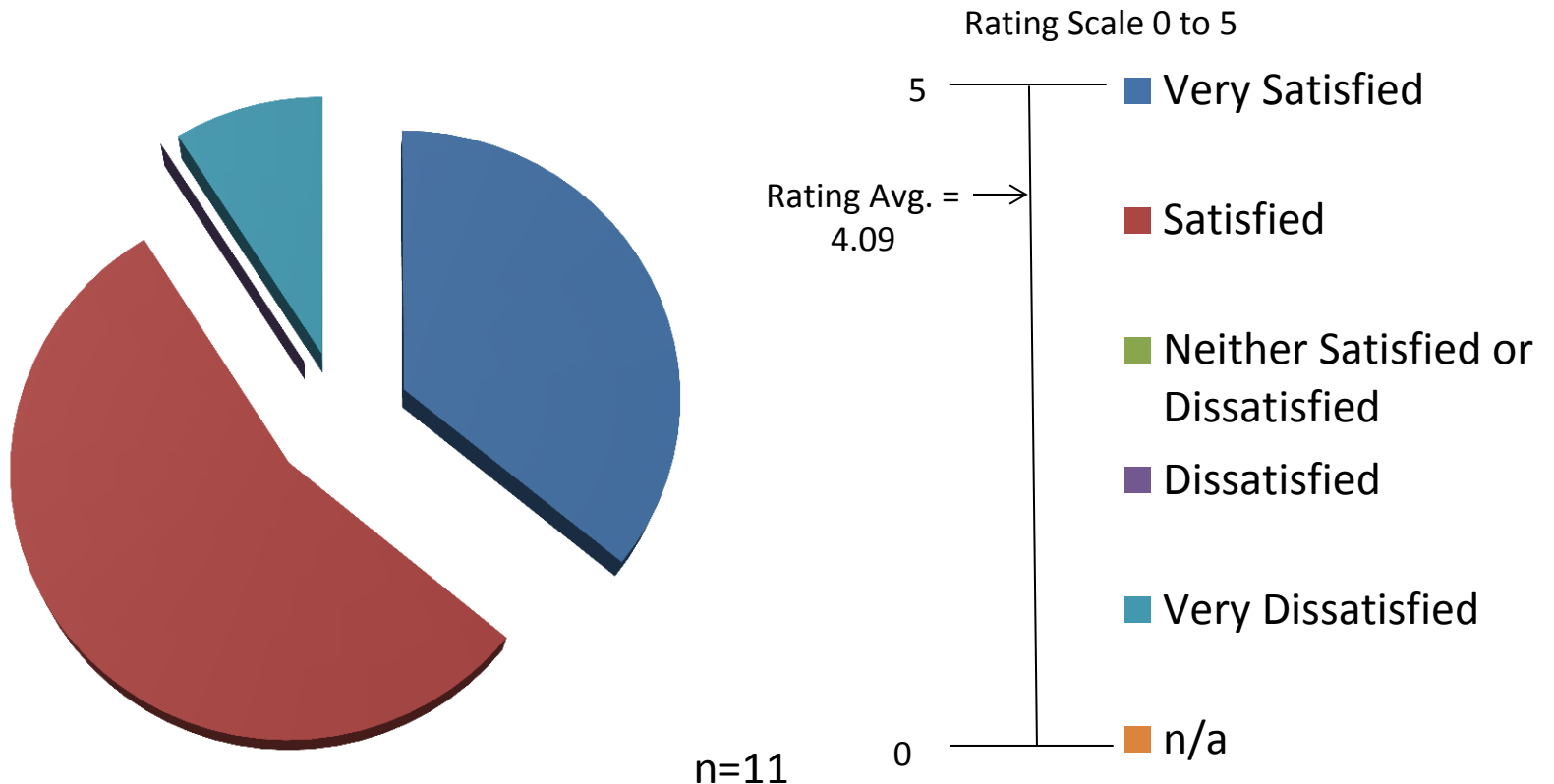
- Plan to Teach Next School Year

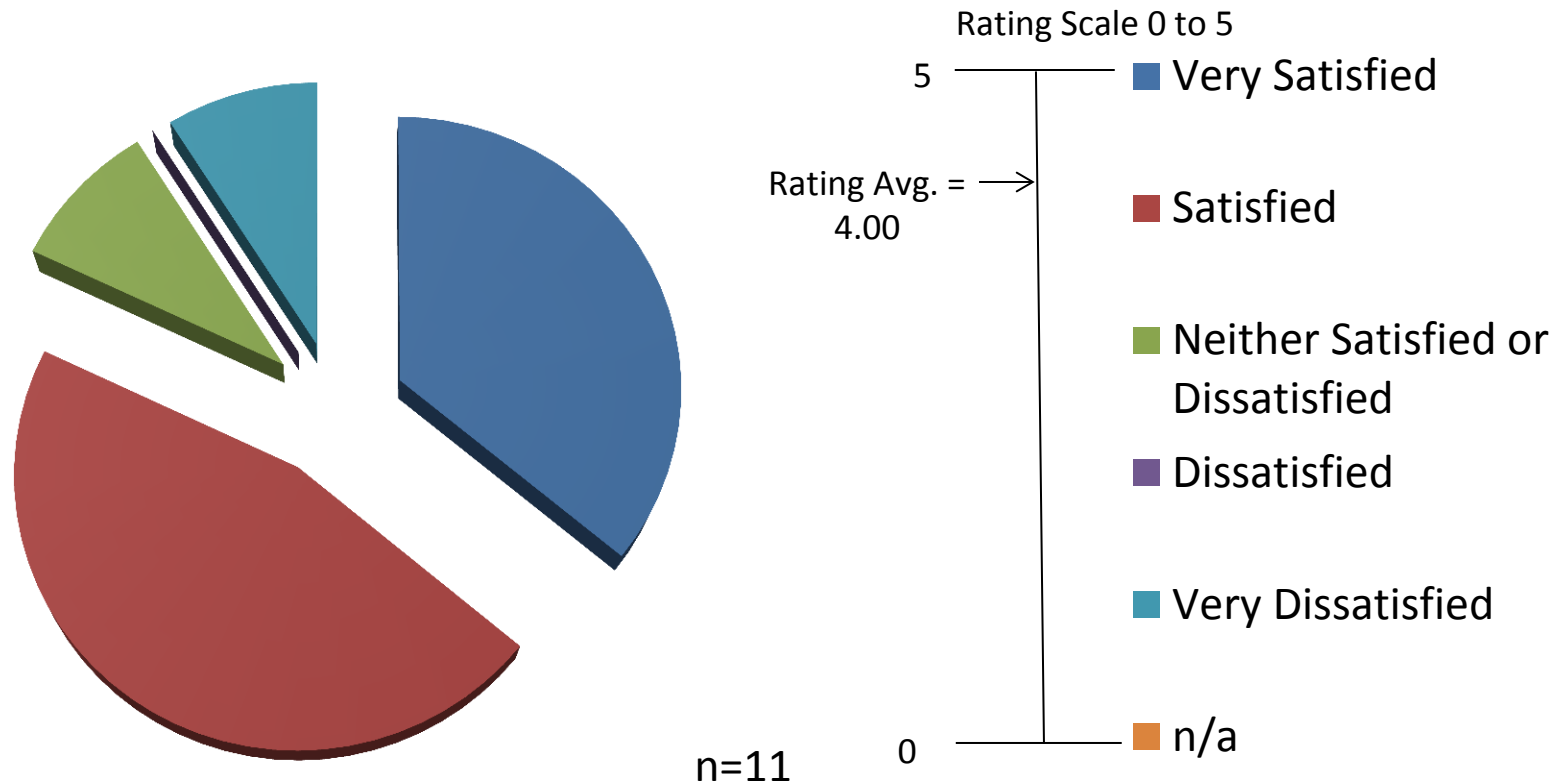
Level of satisfaction among employers regarding the extent to which our completers "Exhibit content knowledge in their area of teaching."

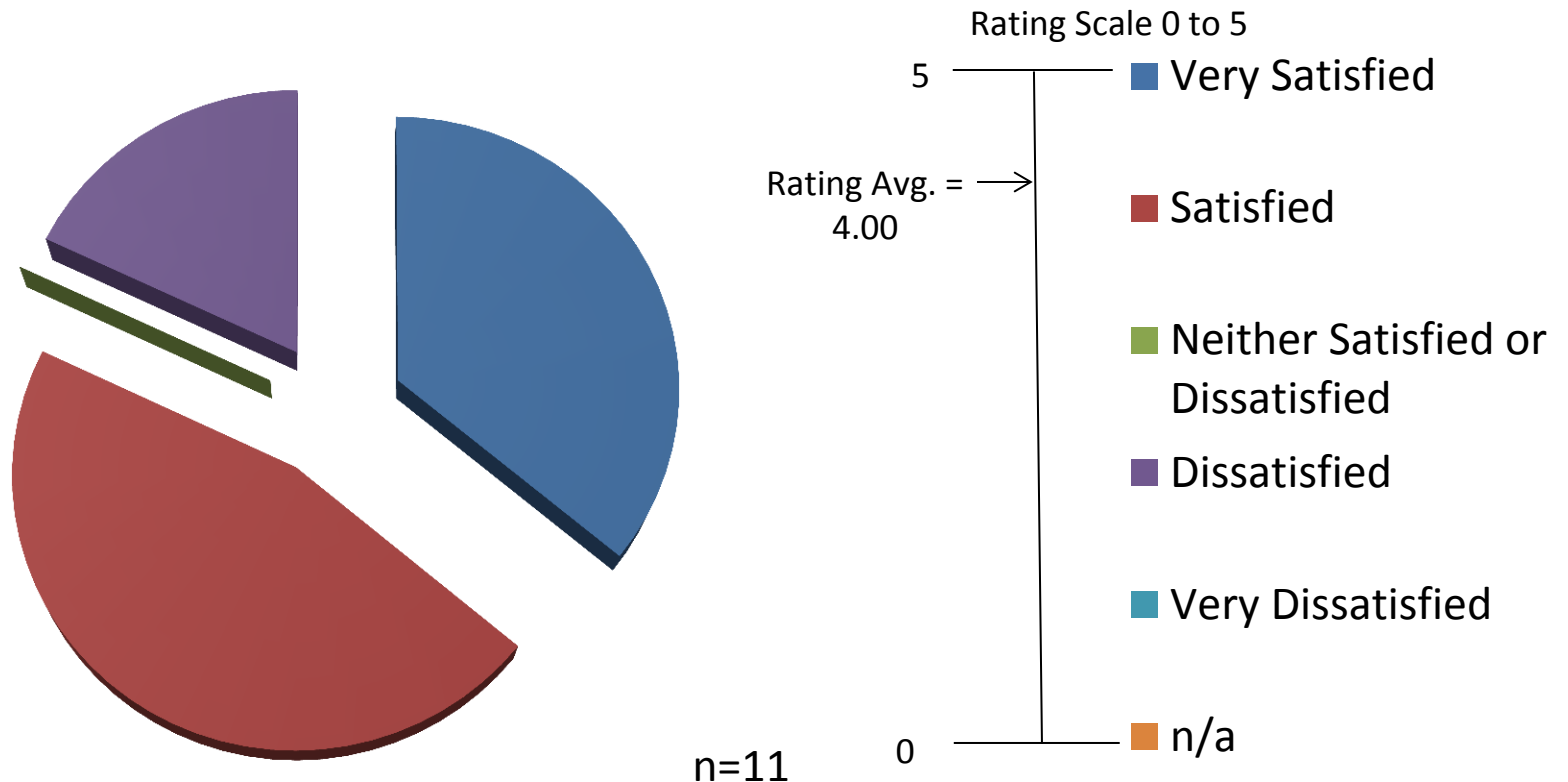

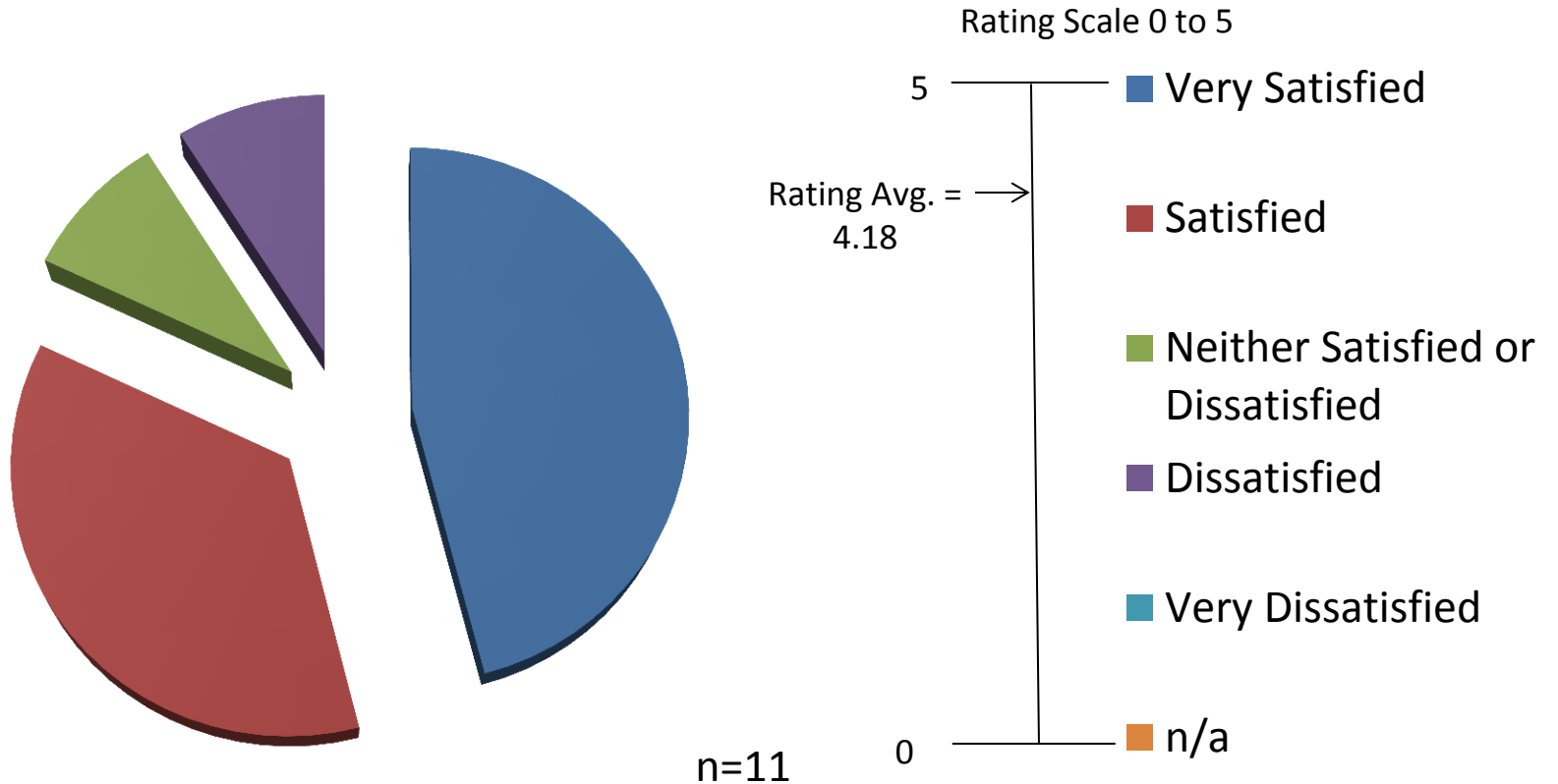

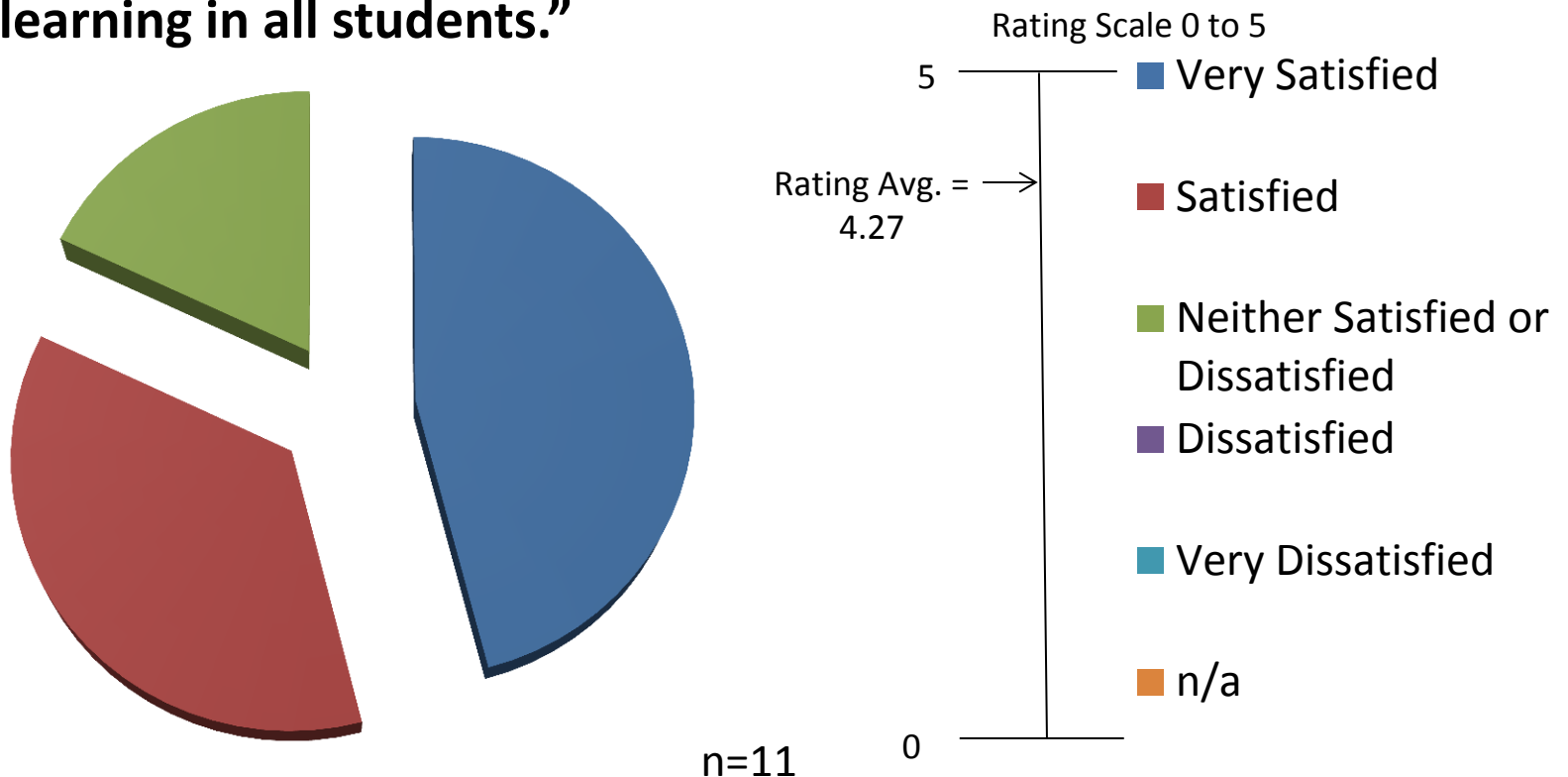

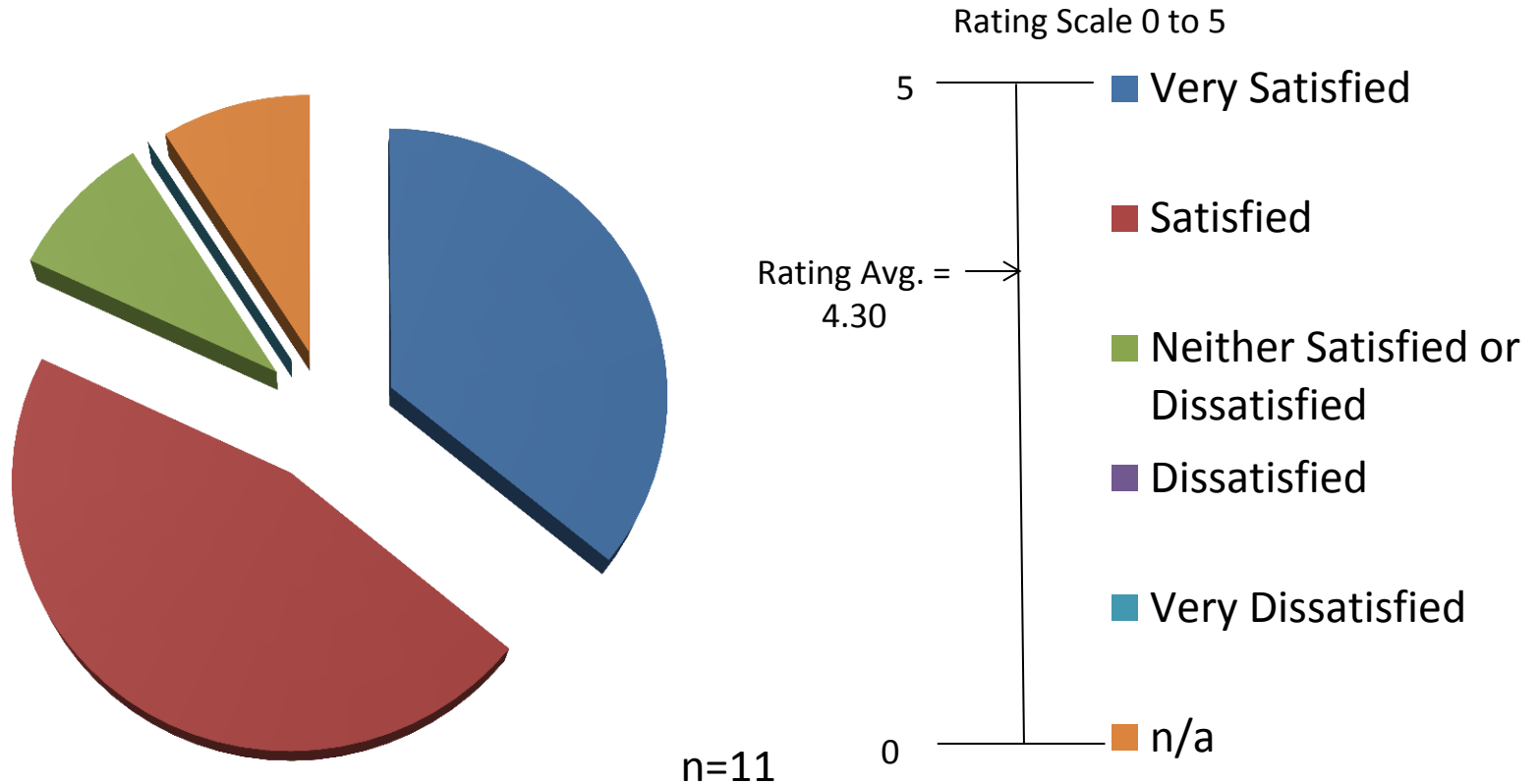

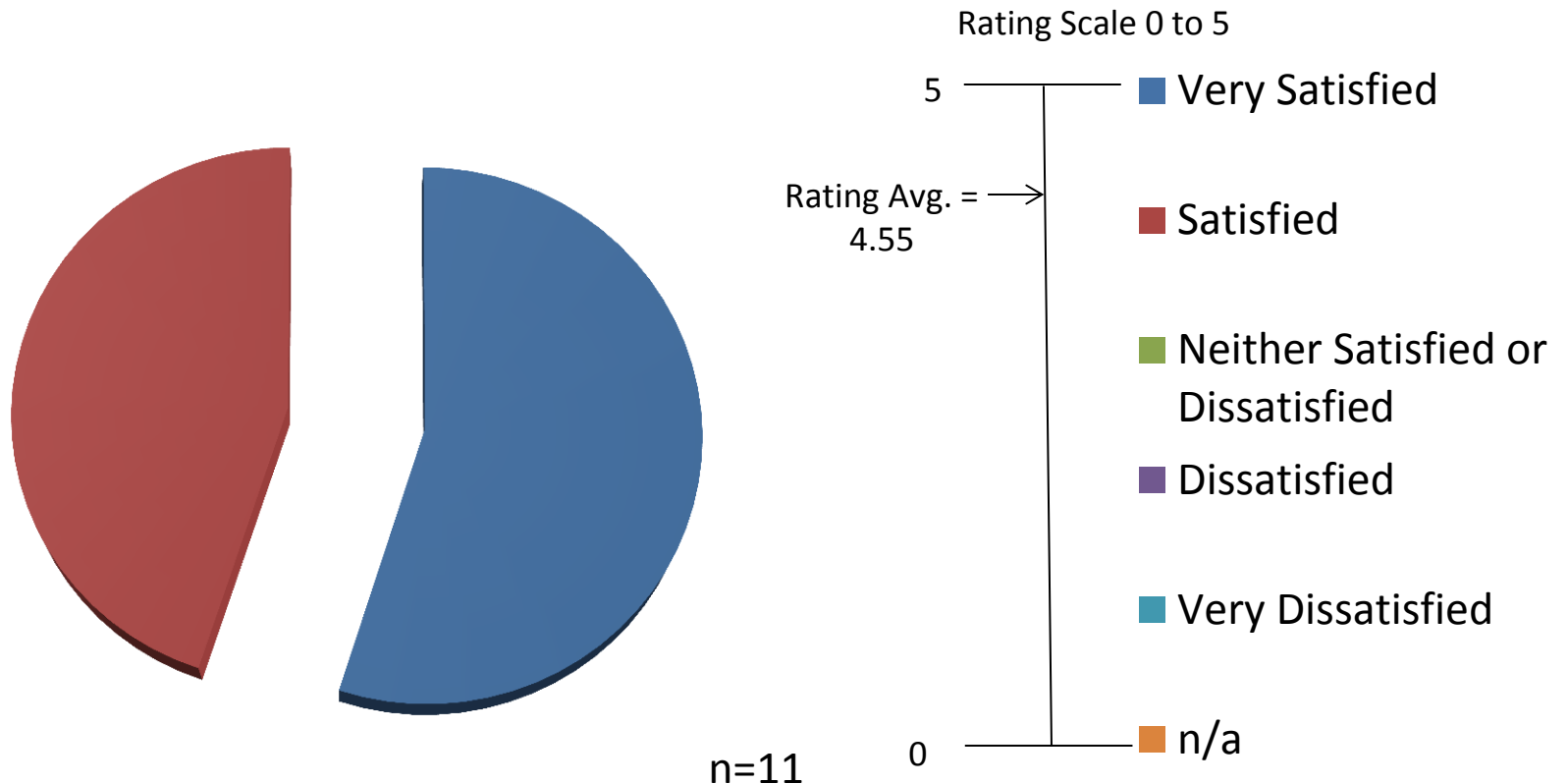

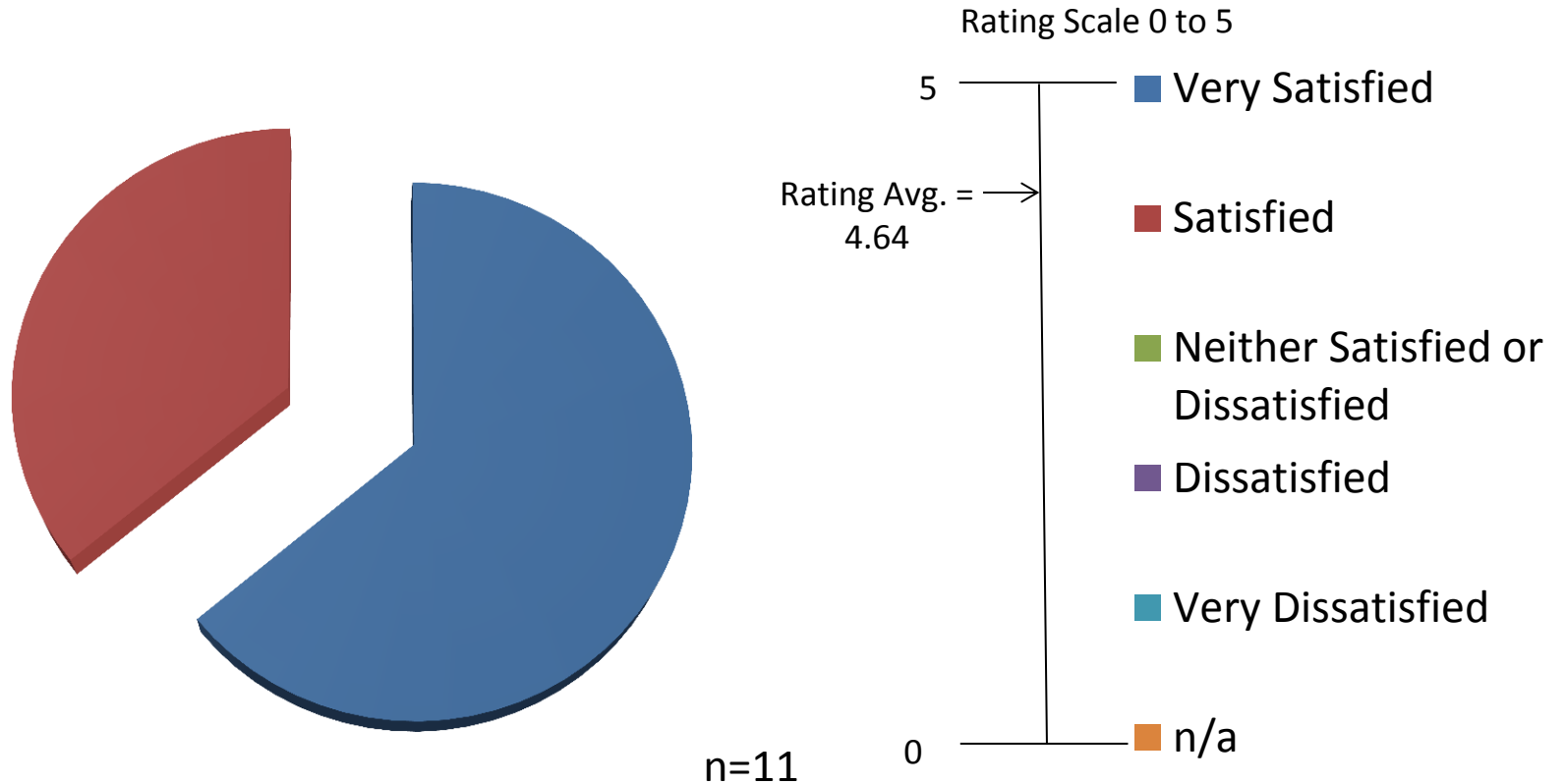

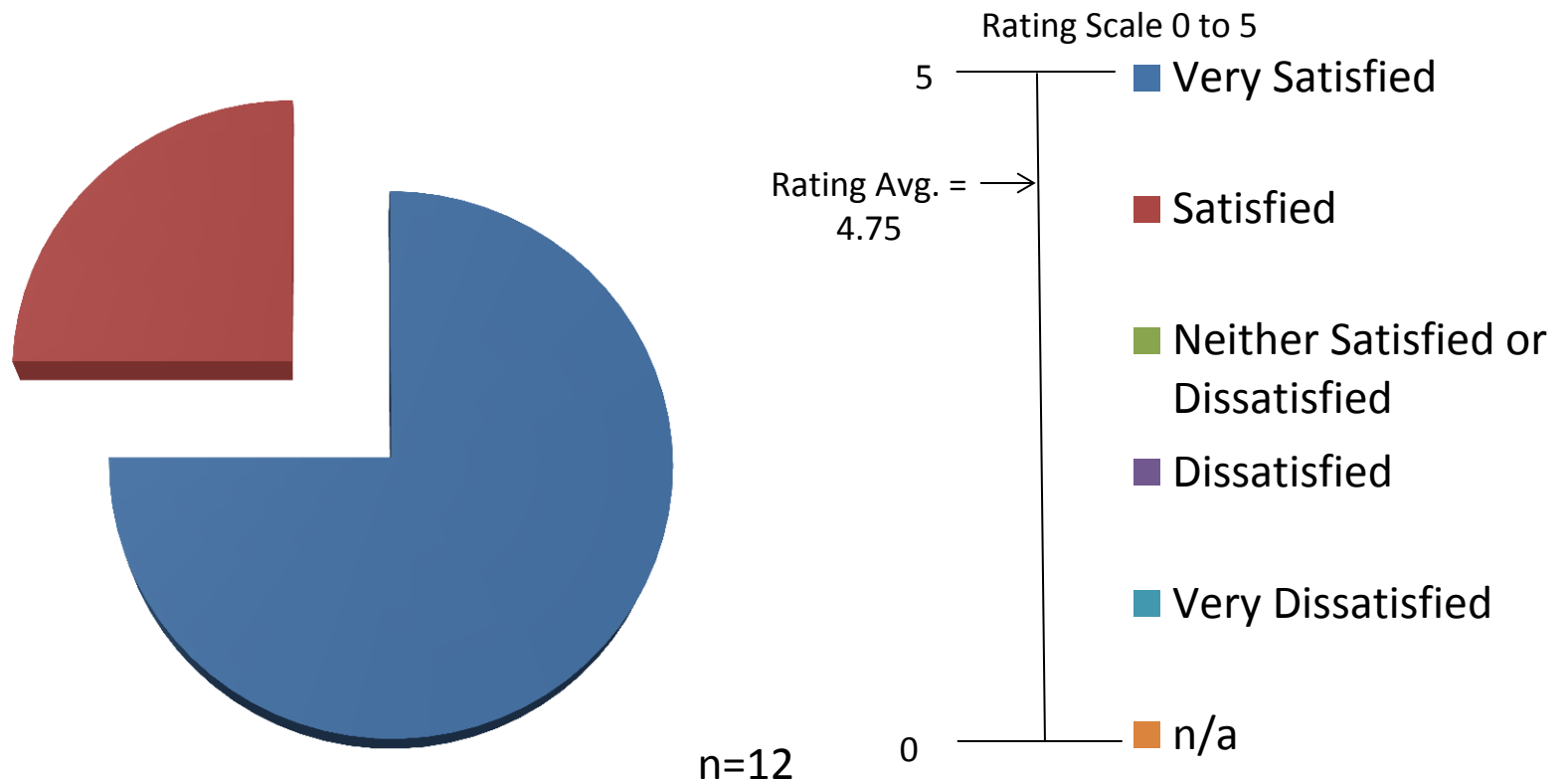

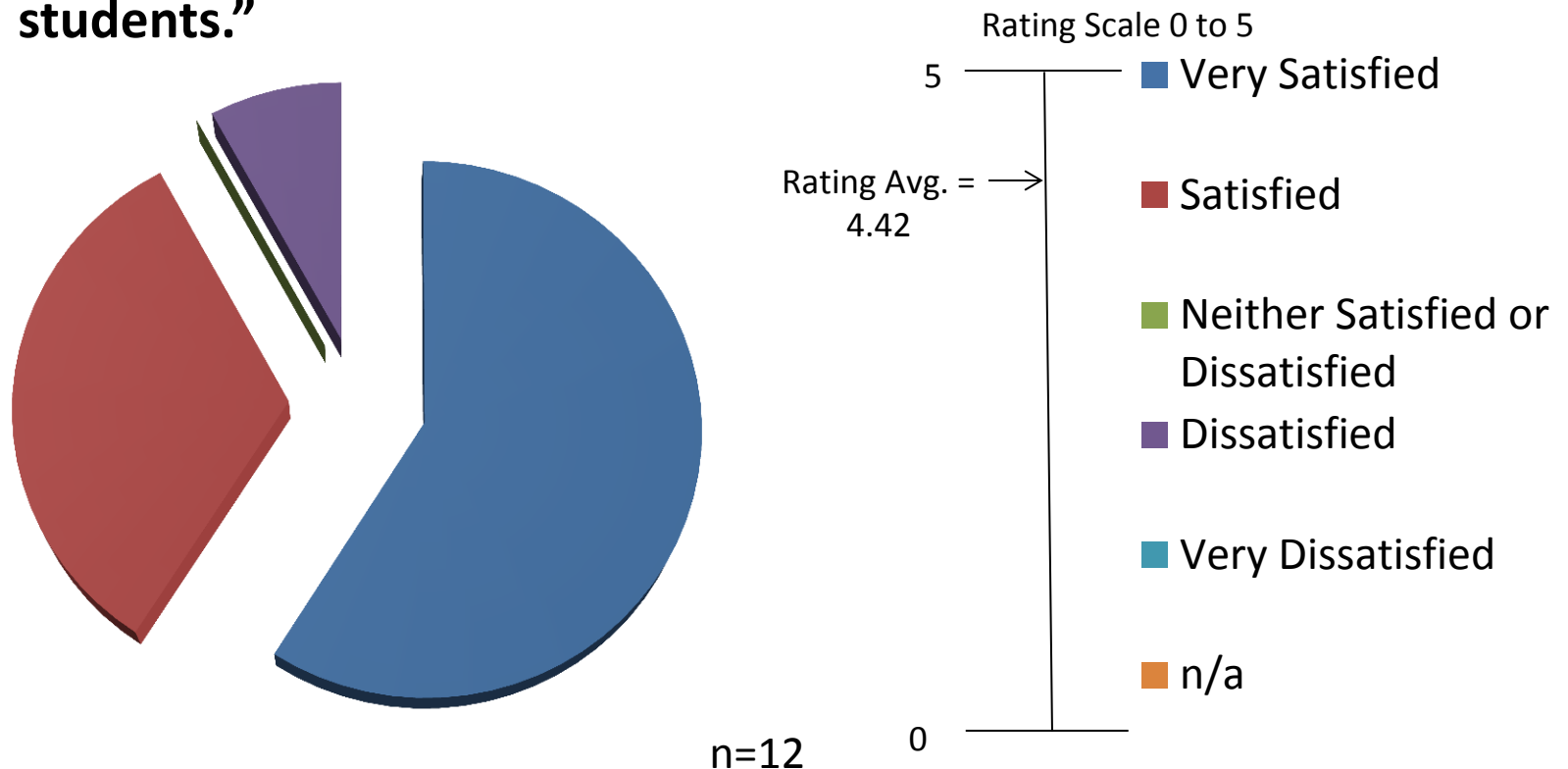

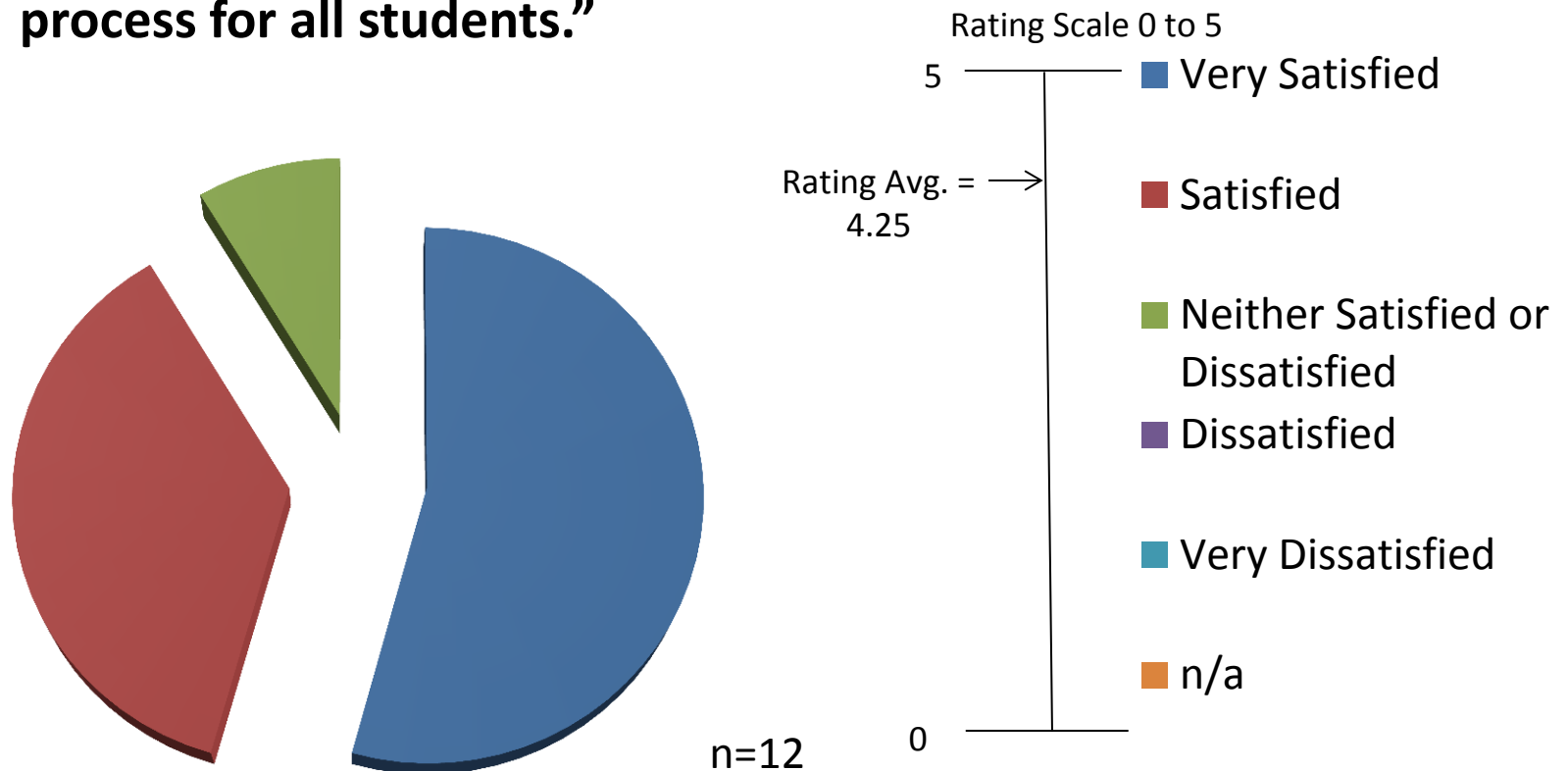
