QUESTIONS FROM OFFERORS - AMENDMENT (JUN 2017)

The solicitation is amended as provided herein. Information or changes resulting from questions will be shown in a question-and-answer format. All questions received have been reprinted below. The “state’s response” should be read without reference to the questions. The questions are included solely to provide a cross-reference to the potential offeror that submitted the question. Questions do not form a part of the contract; the “state’s response” does. Any restatement of part or all of an existing provision of the solicitation in an answer does not modify the original provision except as follows: underlined text is added to the original provision. Question 1	Are there more entrances than just the main door with the existing 3M single aisle than has the old 3M EM gates? Do you want us to quote if this is as an option?
Answer	<u>There is only one exit, the single-aisle, main door that has the existing 3M gate. Please only provide quote as defined in the solicitation.</u>
Question 2	Is there power available at the entrance, and how far from the door is the power source.
Answer	<u>Power source is approximately 6 feet from the existing gate and is accessed via a crawl space.</u>
Question 3	Is there existing conduit in place with the old antennae.
Answer	<u>There is no conduit, but the distance is only approximately 6 feet from the power source; running BX shielded wire is sufficient.</u>
Question 4	Will you want the antennas closer to the entrance door than the present system.
Answer	<u>No, we are satisfied with the antennas being in their existing location.</u>
Question 5	Do you want shielded or unshielded RFID circulation staff pad readers.
Answer	<u>We do not need shielded pad readers.</u>
