<b>Question 1</b>	What weight is the cover and inside pages?
<b>Answer</b>	#70 Gloss Text
<b>Question 2</b>	Are the pages and cover glossy or text?
<b>Answer</b>	It's a gloss text. All pages are the same, there is no difference between cover and interior pages.
<b>Question 3</b>	How many of the 18,000 issues will be mailed?
<b>Answer</b>	See Modification 1 from Amendment 1.
<b>Question 4</b>	As for the delivery of the remaining issues, is it doc delivery or inside delivery?
<b>Answer</b>	Remaining magazines are to be delivered in boxes no heavier than 25lb to the University warehouse dock. We will distribute these magazines internally.
<b>Question 5</b>	The indicia on your "Winter 2018" publication is out of Denver. Would you be willing to mover your account to a location closest to the winner of this RFQ?
<b>Answer</b>	Yes, the indicia can be changed.
<b>Question 6</b>	Will this be a saddle stitch or perfect bound magazine?
<b>Answer</b>	Saddle Stitch.
<b>Question 7</b>	What stock should be quoted for this project?
<b>Answer</b>	#70 Gloss Text or Equivalent
<b>Question 8</b>	Will the print colors be 4/4? What are the print colors?
<b>Answer</b>	The print colors will be a 4/4 process – standard CMYK.
<b>Question 9</b>	Will it require an aqueous coating other than colors printing?
