Dear Colleagues,

Enclosed please find materials in support of my application for an International Collaboration Grant (ICG), which I will use to support leading a travel study course to our partner at the European Academy Otzenhausen (EAO), Germany, during the Late Spring 2017 term. The course, 'European Integration' (POL 341: Special Topics in Comparative Politics) will introduce approximately 10 FMU students to the political study of the European Union, while traveling in Europe. Successful students will earn three hours of upper-level political science credit, which can be applied to a major, minor, collateral, or general education requirement. The course is a partner course with HNRS 286 ('Sustainable Development'), which will be led by Dr. Lorna Cintron-Gonzalez and which will feature an additional 10 students from industrial engineering.

Both courses will be offered as multi-site travel courses, with students completing the first unit in a traditional classroom setting at Francis Marion, before embarking upon a two-week travel component to the EAO campus in Saarland, Germany. While in Europe, my political science students will continue to attend course lectures and activities at EAO, as well as visit the major EU institutional sites, such as the European Court of Justice (Luxembourg, Luxembourg), the European Parliament (Strasbourg, France), and the European Commission (Brussels, Belgium). By the end of the course, students will have first-hand knowledge of the history and purpose of the EU, its political institutions, and its role in the national politics of Europe.

Should my application be successful, I intend to use the ICG to fund my private costs of travel to and lodging at EAO. The combination of roundtrip airfare to Frankfurt, Germany, along with full room and board at EAO, will likely surpass the \$2,500 available via the ICG program. However, this funding nonetheless plays a central role in supporting my ability to offer the course to our students.

1. Course Overview

This course introduces students to the political institutions of the European Union. It provides a historical and theoretical overview of the Union's foundational treaties and initial organizations, as well as a discussion of its contemporary institutions of governance. The second portion of the course will be held in Europe, including site visits to a number of the EU institutions addressed in class. By the end of the course, students will have first-hand knowledge of the history and development of EU institutions, as well as a deep appreciation for the role of the EU in the broader national politics of Europe.

4. Course Requirements

Students will be evaluated on the course material through an in-class exam, a reading quiz, a journal reflecting upon class workshops and site visits in Europe, and participation in all aspects of the travel course program.

A written exam will test student knowledge on the introductory components of the course. This is the main exam for the class and will test material on the European Union's historical development, its foundational and governing treaties, and its major political institutions. The exam will be completed on campus at Francis Marion University, prior to departure for Europe. A brief reading quiz will test student understanding of additional assigned materials, covered while at the European Academy.

A **reflection journal** will be submitted at the end of the travel portion of the course and will address the course's site visits, workshops, and guest lectures. By assigning an evaluative travel journal, students will return from their travel with a record of the many new places and people that they will have experienced, as well as consider their relevance to the course materials.

Attendance and participation are absolutely mandatory at all meetings, workshops, and site visits. Students will be penalized at a rate of 5% off the final course grade, per absence, for all unexcused absences. Students who miss more than one class session, prior to travel to Europe, will be dropped from the course and will not travel with the group. No refunds will be offered by the program. Absences may only be excused ahead of time and must be accompanied with sufficient documentation. Do NOT test me on this point.

Students are responsible for their preparation and participation in class. If I feel that student preparation is inadequate, I reserve the right to jeopardize any portion of your course grade through the use of unannounced quizzes.

5. Classroom Policies

You are responsible for using your **FMU email account** and checking it regularly. I am not responsible for communicating with students via private email addresses and will only initiate contact with students on their FMU email handles.

All students are required to follow Francis Marion University's policies regarding cheating and plagiarism. I expect strict adherence to the requirements discussed at length in the current edition of the Student Handbook. If you cheat or are caught plagiarizing, you will receive a grade of zero for the assignment. I will refer all cases of suspected academic dishonesty to the Provost.

Cell phones and other wireless devices may not be during classroom lectures and activities.

If you have a **documented learning disability** and require assistance, please consult with the Office of Counseling and Testing as early as possible in the term. Please then present the paperwork to me within the first two class sessions and schedule a time outside of class for us to develop a plan to best meet your needs.

Late work will not be accepted in this course, due to the short time period in which we meet.

Alternate exam times must be scheduled well in advance and should be supported by appropriate documentation. Students who miss the written exam without prior arrangements for a make-up will <u>not</u> be allowed to retake that exam. Alternate exams may vary in form and content from the main class exam.

Course Plan and Purpose

Building upon the success of the 2015 and 2016 travel study courses to Otzenhausen, Germany, the political science and physics departments will offer two separate courses at the European Academy of Otzenhausen (in Saarland, Germany) during Late Spring 2017 term. POL 341 (Special Topics: European Integration) and HNRS 286 (Special Topics: Sustainable Development in Europe) will be taught in a unique travel study format, with instruction at both Francis Marion University and in Europe. Students will enroll in either of the two courses. Those who successfully complete the course will receive three credit hours of upper-level political science (for POL 341) or three hours of FMU Honors/ physics credit (HNRS 286), which may be applied to a student's major, minor, or collateral in their relevant degree plan or applied to general education credits in the social or natural sciences.

2. Course Dates and Locations

The May period (Late Spring Term) runs from 9-26 May 2017. During the first part of the term, students will attend traditional classes on the FMU campus, where they will be taught by either Dr. William Daniel (POL 341 students) or Dr. Lorna Cintron-Gonzalez (HNRS 286 students). These classes will cover the introductory course material and prepare students for the travel study experience.

During the second part of the term, students will travel to Europe for ten nights (17-28 May), where they will be housed at the Europäische Akademie Otzenhausen (EAO) in Saarland. Students will take part in additional course instruction from FMU faculty, as well as interactive workshops with European practitioners and researchers in their respective fields. They will also travel to site visits in the areas that are relevant to their field (i.e., EU institutions in Luxembourg, France, and Belgium for POL 341; factories and sustainable development projects in Belgium, France, and Germany for HNRS 286).

3. Lodging and Travel

While in Europe, FMU students will be lodged with full board on the EAO campus. EAO offers modern and spacious dormitory rooms, with wifi connectivity and multi-lingual televisions in each room. The EAO campus houses a library, multiple dining facilities, recreational opportunities, and a conference center for course instruction. EAO will coordinate all aspects of student travel while in Europe, from our arrival at Frankfurt airport, to all site visits, until our return to the USA. EAO will also provide all meals in a family dining configuration (including vegetarian/kosher/halal options, as requested).





4. Potential Site Visits

Otzenhausen (POL 341 & HNRS 286) – EAO is situated in the Nonnweiler region of Saarland, which is Germany's southwestern-most province. The region is bordered by Luxembourg to the west and France to the south. Close to the EAO campus are a series of dense, green forests and fresh lakes. Otzenhausen is home to one of the largest Celtic fortifications still standing, dating from the 5th century BCE.

Brussels (POL 341 & HNRS 286) – Home to many of the European Union's governing institutions, Brussels is officially French-Dutch bilingual, but is also known as the 'capital of Europe,' due to the dozens of nationalities that call the city home. Our visit to Brussels will include a stop at the European Commission, as well as the brand-new Parlamentarium museum, housed at the European Parliament.

Strasbourg (POL 341 & HNRS 286) – Strasbourg is the official home of the European Parliament, as well as the Council of Europe and the European Court of Human Rights. Sometimes referred to as the 'Venice of the North,' Strasbourg is a city of canals, situated at the confluence of French and German culture.

Luxembourg (POL 341) – The Grand Duchy of Luxembourg is one of Europe's smallest countries, but is packed with important history. Luxembourg City is a beautiful, medieval town, perched on a fortified hill, with many of its ancient ramparts still open to visitors. Our stop in Luxembourg will include a trip to the European Court of Justice, the EU's highest court.

Sustainable Manufacturing Site Visits in the SaarLorLux Region (HNRS 286) – Numerous European companies and research centers have adopted sustainable manufacturing practices. These companies work to tackle how to best create products, deliver services or implement new technology "through economically-sound processes that minimize negative environmental impacts while conserving energy and natural resources" (epa.gov). Our site visits will include major commercial partners that are working in this vein, as well as research centers attempting to develop new technologies.

5. Tuition and Fees

- A. Course Tuition (~\$1500): three credits of summer tuition
- B. Program Fee (\$2000): covers travel, room, board, and all meals during travel
 - Round-trip travel from Florence, SC, to Otzenhausen, Germany
 - Lodging and all meals at EAO
 - Travel and Site Visits provided by EAO

Total Cost: approximately \$3500 (SC in-state student cost)





6. Course Requirements

Students must have successfully completed either POL 101 or POL 103, prior to the start of the Late Spring 2017 term, in order to enroll in **POL 341**. POL 103 is recommended.

While no formal prerequisite exists for **HNRS 286**, preference will be given for students using the course for FMU Honors hours and/or who have already taken coursework in the natural or physical sciences. The Department of Physics and Astronomy may also grant physics credit for this course, at their discretion.
