Thank you for your letter, received in our office on March 21, 2016, seeking approval to close an off-campus instructional site, effective fall 2012. The site is:

The closure is effective fall 2012, the date students were last admitted at the site. The institution offered courses under contract to the school district and the contract ended. No additional cohorts were admitted at this site. All students enrolled at the site completed their programs of study as originally planned with no disruption.

As a reminder, all program and site closures require teach-out plans and approvals from the Commission even if the institution's plan is to continue offering courses as planned until all students have completed. The institution has an affirmative obligation to seek closure approval from the Commission at the time the closure decision is made and prior to the cessation of instruction.

As a point of information, with the closure of the Dillon School District Three and Hartsville Middle School sites, the Commission has one open site recorded for the institution: Trident Technical College Mount Pleasant Campus, located at 1125 John Dilligard Lane in Mount Pleasant, SC.
