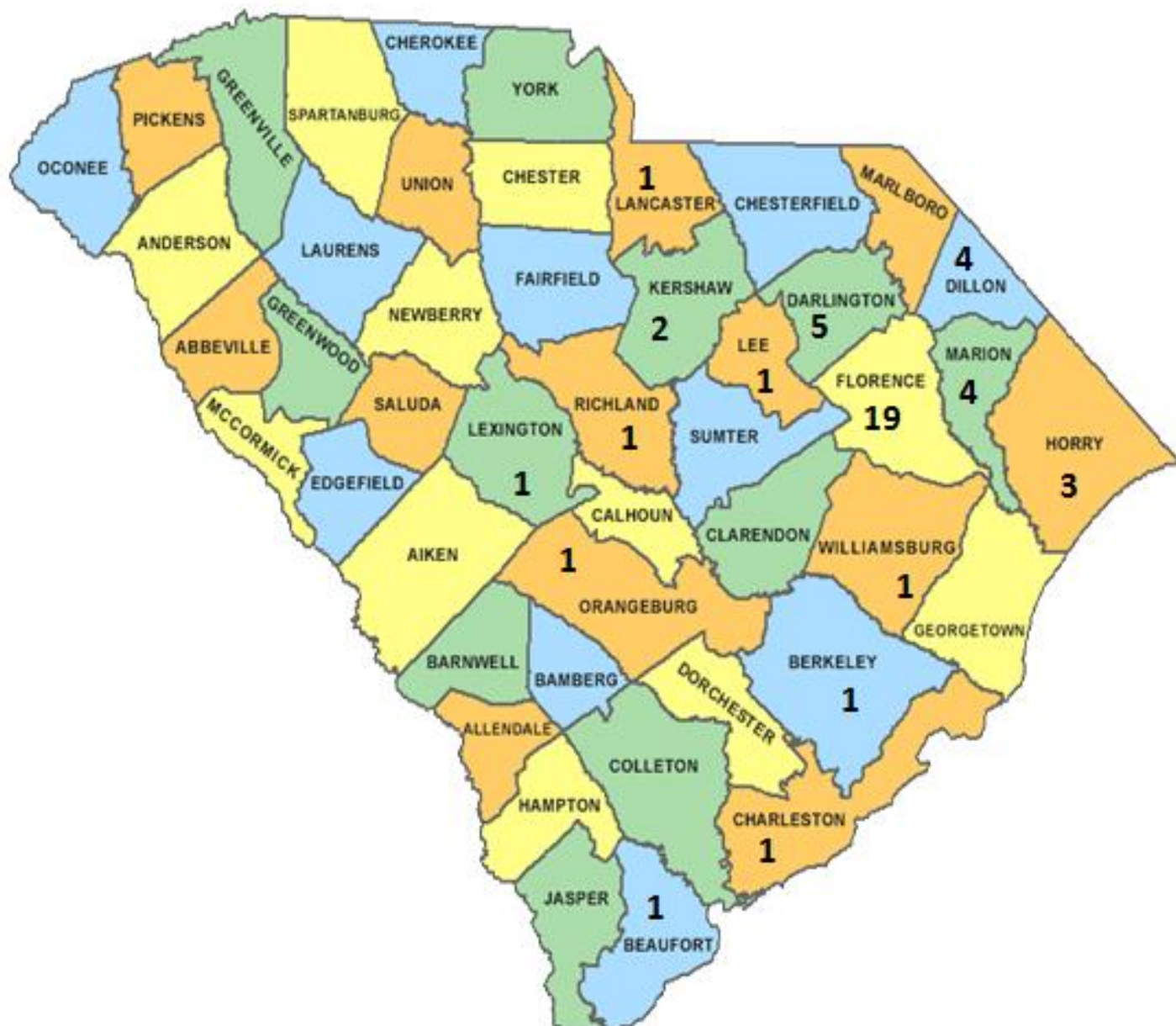

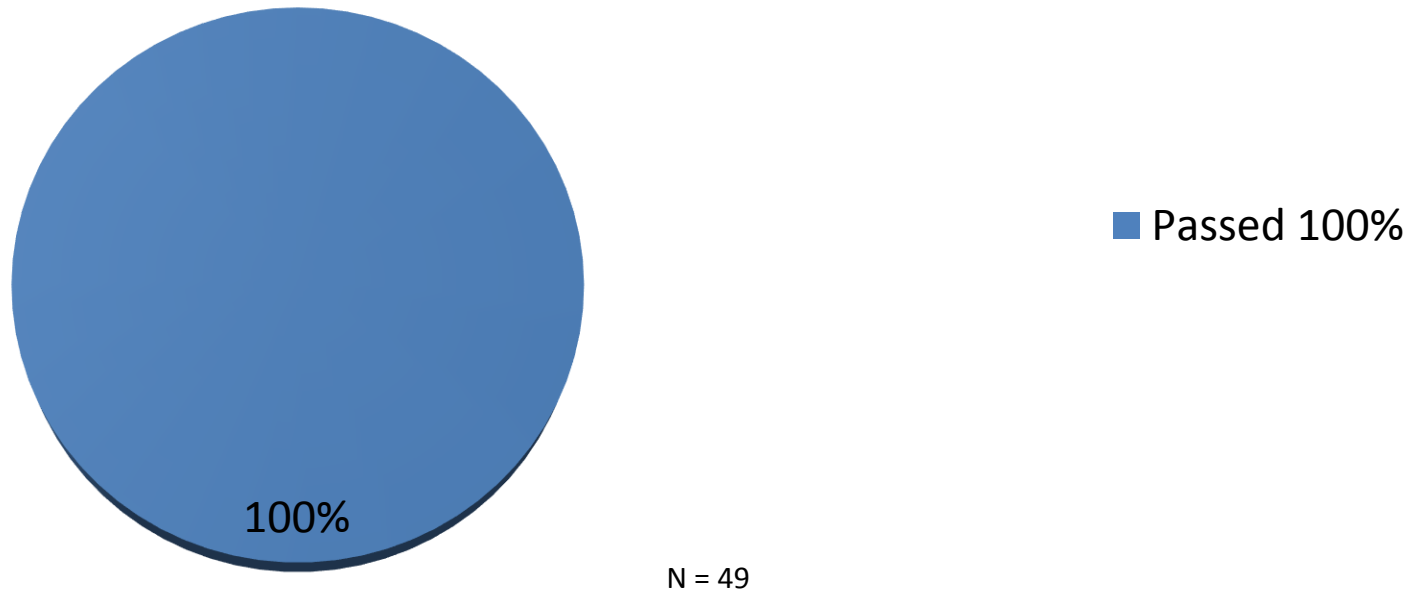

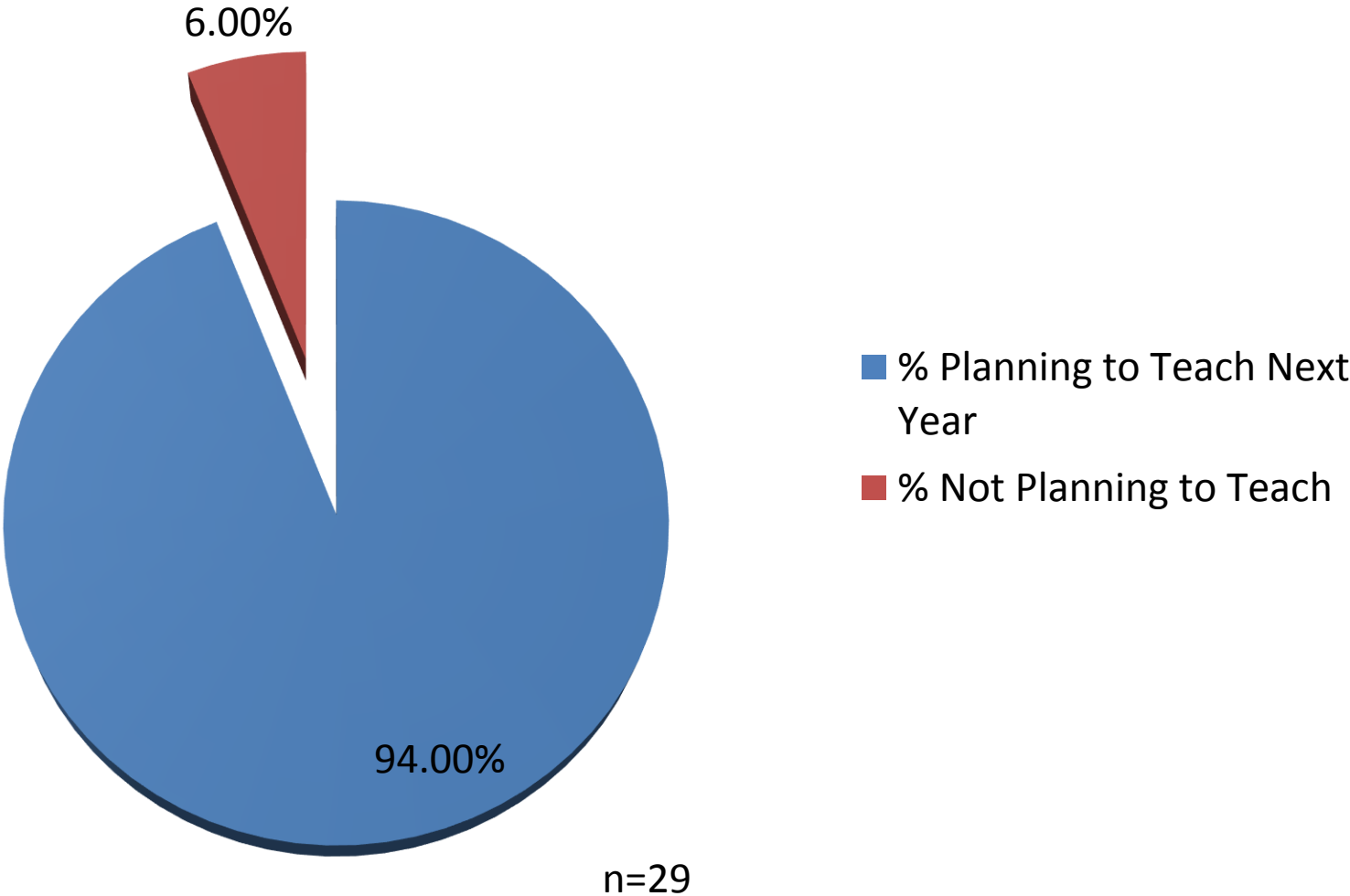


Graduate Performance on Licensure Exams

100% of the 2016-2017 Graduates passed the licensure exams required to teach in South Carolina.



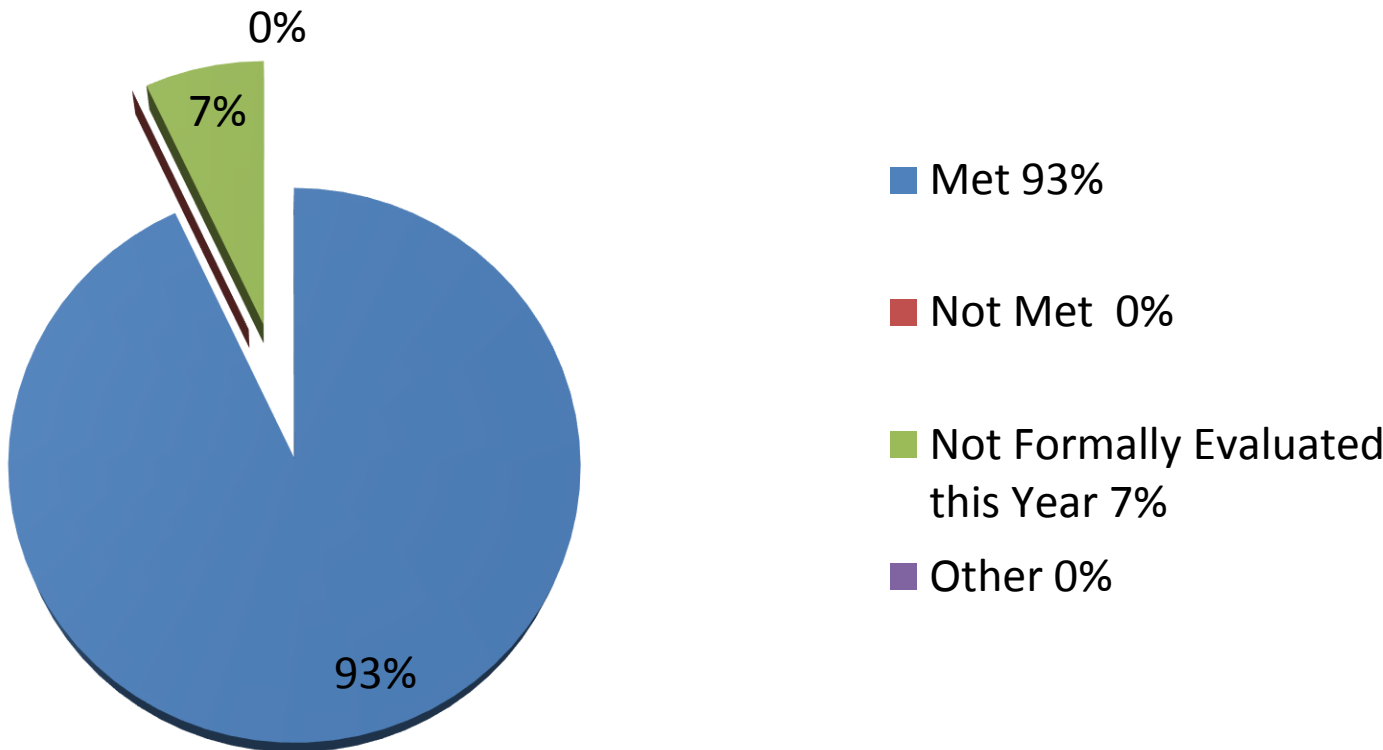
Percentage of our 2016-2017 completers who plan to continue to teach next year?

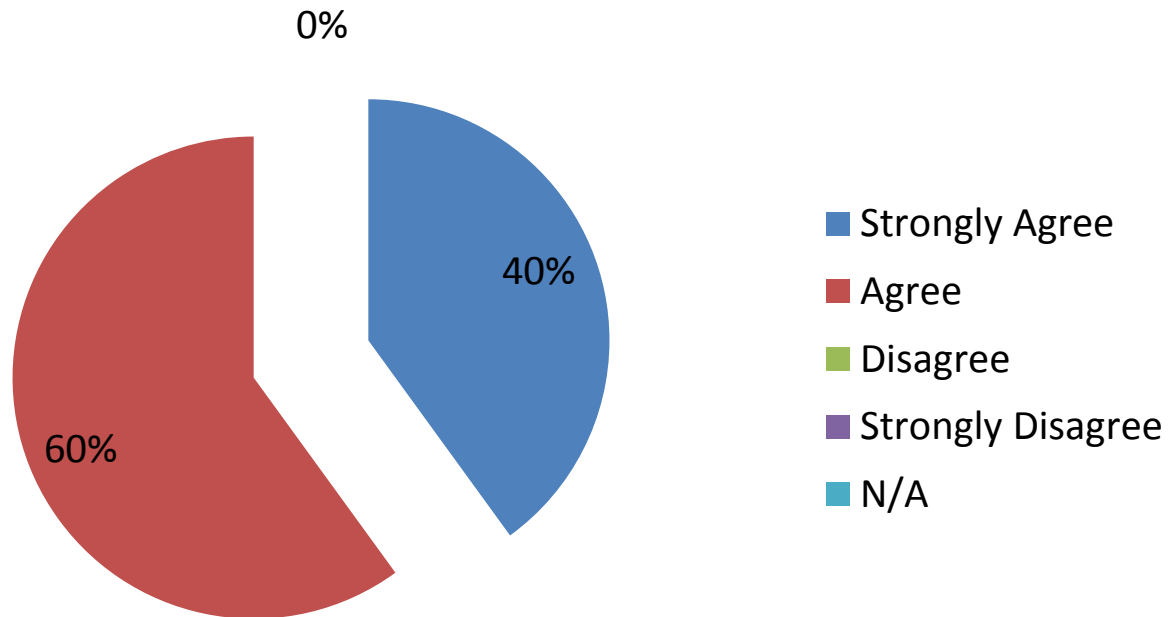

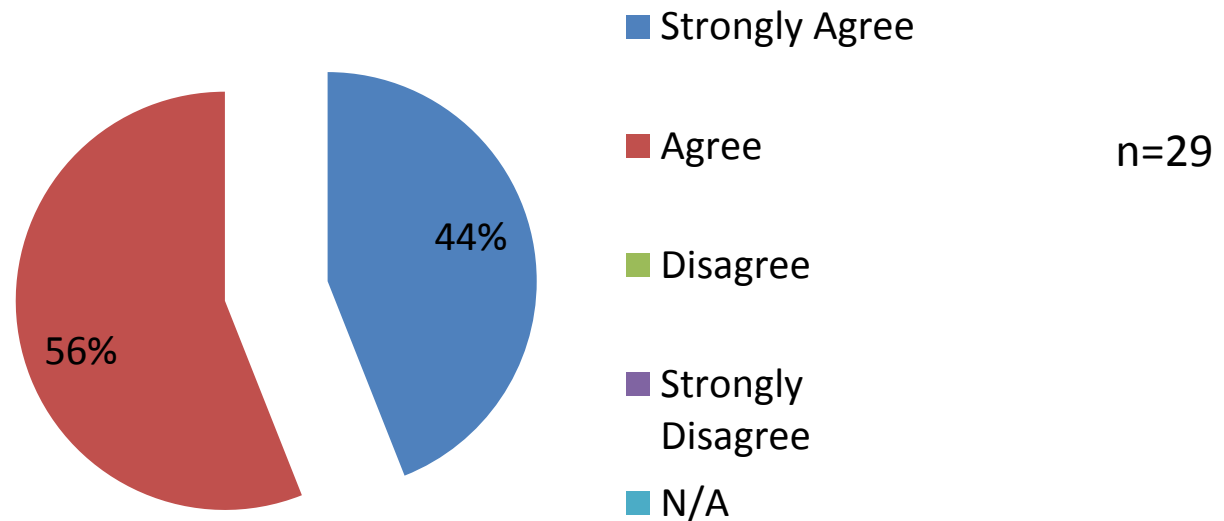

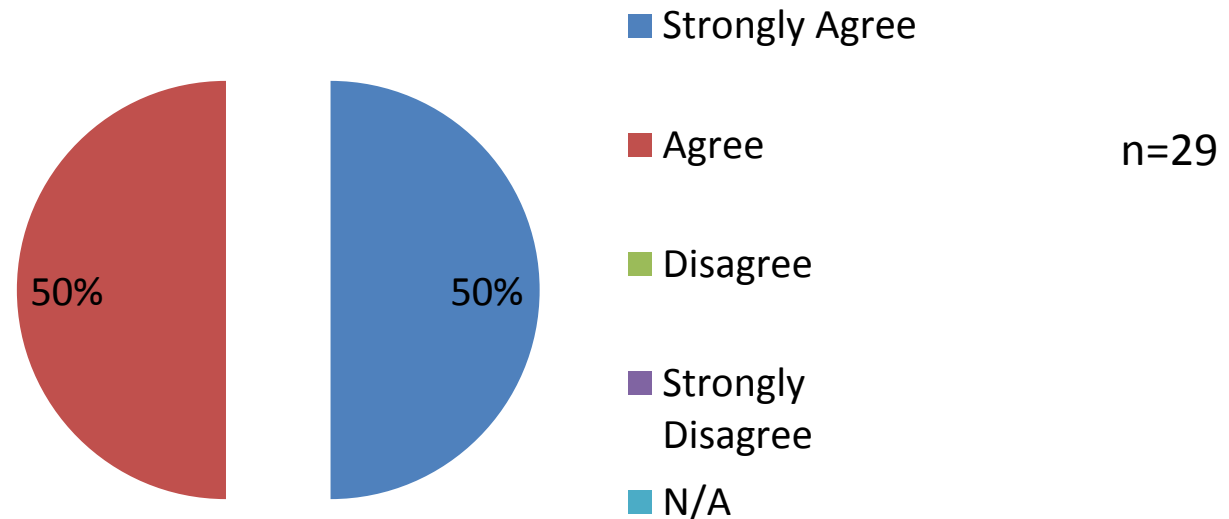

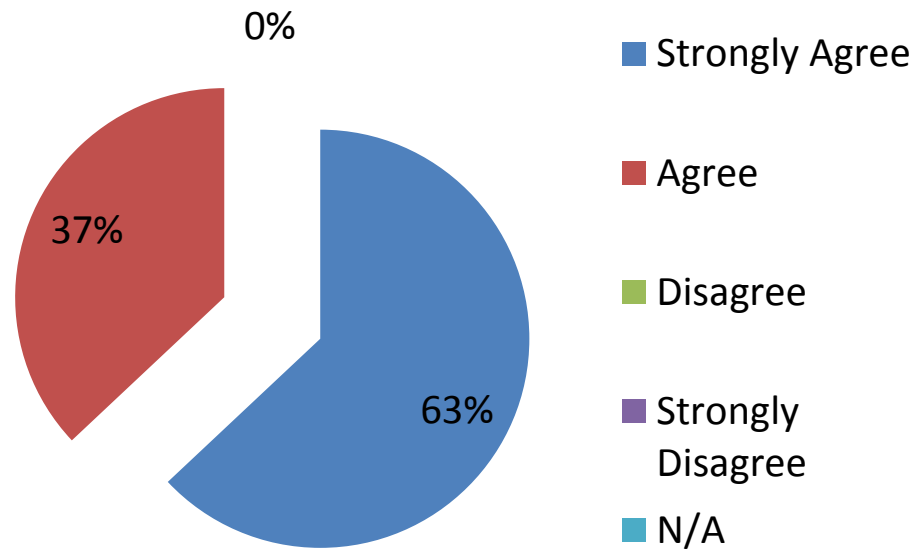

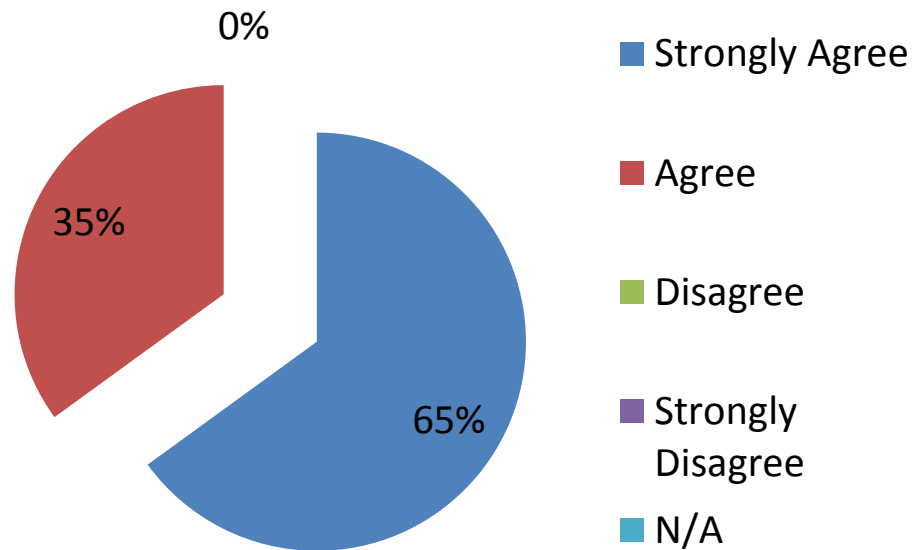

Summary of notable responses...

- Lesson Ideas and Strategies, Classroom Management Strategies, Vast amount of situation examples.
- SLOs and Lesson Plans. FMU was harder than my school and district.
- I feel that I was more prepared for my first year of teaching than some of my fellow co-workers from other colleges. Many had never heard of an SLO and had no idea how to go about completing the process. I am so grateful to FMU for taking the first few weeks to walk us through the process and give us examples of how to complete an SLO.
- I know how to plan and carry out a lesson based on the South Carolina Teachers Standards rubric, and how to monitor and adjust lessons based on assessments from my students.
- The lesson plans are a strength of FMU. Even though I do not write the FMU temple, I often think back about things such as purpose and relevance when planning and teaching my lesson.
- I believe that the variety of instruction that we were prepared with helped to be able to teach all subject areas. We were given many resources and ideas to take with us. Also, I believe that FMU was very prepared and ahead of the game with the 4.0 rubric that was used. That is the same rubric that my district is using, and it was great to have already been expose to it.
- FMU did a wonderful job teaching me about classroom management. I also feel as though I got strong instruction on assessments, how to write them, and how to use them.
- The courses were rigorous and prepared us for our jobs as educators.
- Lesson planning was a huge help into planning my lessons for my school.
