#### Kappa Alpha Order

**Violation Date:** 10/25/2016  
**Charge Date:** 10/26/2016  
**Investigation Initiated:** 10/26/2016 Organization was placed on Interim Suspension  
**Incident Description:** University was alerted by the fraternity advisor of off-campus incident that was verbal with no evidence of physical contact. Due to the nature of the verbal context, the incident met the criteria for hazing activity  
**University Charge(s):** Organization was charged with violation of hazing policy.  
**Findings:** Responsible  
**Sanctions/Resolution:** Suspended until 2/5/17. Nine officers removed from office; extensive risk management and hazing education training imposed.

#### Delta Sigma Theta

**Violation Date:** 2/2016  
**Charge Date:** 3/14/2016 Organization was placed on Interim Suspension  
**Investigation Initiated:** 3/11/2016  
**Incident Description:** University was notified by the South Atlantic Regional Office of alleged hazing activities at an off-campus location. Potential new members were required to attend excessively long meetings and stand for long periods of time and coerced to eat particular foods Due to the nature of the activity, the incident met the criteria for hazing activity.  
**University Charges(s):** Organization was charged with violation of hazing policy.  
**Findings:** Responsible

**Sanctions/Resolution:** Suspension effective immediately until 5/31/2019; due to past behaviors, probation for one academic year upon reactivation on campus, if determined the chapter will be allowed to return; educational success planning training.

### Tau Kappa Epsilon

**Violation Date:** 4/13/2015  
**Charge Date:** 4/14/2015 Organization was placed on Interim Suspension  
**Investigation Initiated:** 4/14/2015  
**Incident Description:** Vandalism of University owned/controlled property by potential new members of the fraternity. Individual students took responsibility for property damages. However, there was enough evidence to hold the fraternity to a level of responsibility due to a failure in managing the process thereby affecting the campus community.  
**University Charge(s):** The fraternity received an admonition with conditions.  
**Findings:** The fraternity was held responsible for ineffective recruitment oversight.  
**Sanctions/Resolution:** Probation effective immediately through 5/31/2016; Fraternity also required to complete an educational and success action plan.

### Omega Psi Phi

**Violation Date:** 2/2015  
**Charge Date:** 3/16/2015 Organization was placed on Interim Suspension  
**Investigation Initiated:** 3/18/2015  
**Incident Description:** The fraternity failed to follow University policy regarding new membership intake activities. Fraternity failed to submit intake documentation for official approval before conducting membership intake activities.  
**University Charge(s):** Failure to comply with the directions of an University official; violation or attempted violation or incitement of others to violate policy.  
**Findings:** Responsible for compliance violations.  
**Sanctions/Resolution:** Due to the failure to be compliant with the membership intake process, the potential risk of hazing was heightened. Therefore, the fraternity was suspended immediately until 12/31/2015 with probation through 5/31/2015. In addition, educational effectiveness training was required in addition to creating a Success Action Plan.
